Weekly	Between Monday to Friday*	Rs.150/- and in multiples of Rs.1/- thereafter.	40

*The investors can choose any Business Day from Monday to Friday (In case any of a non - business day, the transaction will be executed on the next business day of the Scheme). In case the SIP debit day is not specified or in case of ambiguity the default Day shall be Friday.

#Minimum Weekly SIP instalment amount for all relevant Schemes, except LIC MF ELSS Tax Saver where minimum amount will be Rs. 500/- and in multiples of Rs. 500/- thereafter.

Necessary/ incidental changes in the above regards shall be carried out in the SID and KIM of the Select Schemes of LIC Mutual Fund.

This Notice cum Addendum forms an integral part of the SID and KIM of the Select Schemes of LIC Mutual Fund as amended from time to time.

All other terms and conditions of the Select Schemes of LIC Mutual Fund will remain unchanged.
